It appears Obbie Frabotta, referred to in reairtel, is identical with case captioned "ALBERT FRABOTTA, AKA.; AR," OO:CG, Bufile 92-5782, CGfile 92-689.

It appears further that Chuckie English is identical with case captioned "CHARLES ENGLISH, aka.; AR," OO:CG, Bufile 92-5347, CGfile 92-917.

The Chicago Office is instructed to immediately furnish Denver photographs, descriptions and background information concerning Frabotta and English. In addition, Bureau desires that Chicago maintain close contact with informants and other sources in a position to furnish information on Frabotta and English in order that their current activities can be determined on an up-to-date basis. The Bureau, Denver and Miami should be advised immediately in the event information is developed to indicate either one or both of these individuals may be planning to travel to Denver.

The Denver Office should maintain close contact with DN 249-C for any information pertinent to this matter.

NOTE: Frabotta and English are subjects of current Top Hoodlum investigations by the Chicago Office. Frabotta alleged to be strong-arm man and syndicate killer in Chicago area and has been observed in the presence of Alderisio on several occasions. English is alleged to be a lieutenant of Chicago hoodlum Sam Giancana and his organization controls on-track betting at Sportsman's Racetrack, Cicero, Illinois.

DN 249-C reported today that some four years ago, he was in frequent contact with FELIX ALDERISIO in Chicago and at that time ALDERISIO's close associates were OBBIE FRABOTTA and CHUCKIE ENGLISH who were generally rumored to be muscle men for ALDERISIO who would ordinarily be called upon to handle any "muscling" operations for him. Informant expressed the opinion that if ALDERISIO has any intention of attempting to do away with EGAN in Denver or elsewhere, it is his belief that FRABOTTA or ENGLISH might be assigned to handle the job.

If recent investigation of ALDERISIO appears to substantiate this information, it is suggested that complete descriptions and photos of FRABOTTA and ENGLISH be forwarded to Denver immediately together with most recent photo of ALDERISIO.
