1. On the above mentioned date, Mrs. Patricia BOWEN, 22 Van Order Drive, KINGSTON, Ontario, was interviewed. Mrs. BOWEN stated that GROSSI was her ex-husband and that same had been in KINGSTON to visit with his son on the 29 JUNE 74. Mrs. BOWEN further stated that GROSSI had only stayed for a few minutes as she would not let her son see his father.

2. Mrs. BOWEN informed that GROSSI was driving a huge white van (Motorhome) with CALIFORNIA licence plates, however, she could not remember the number. GROSSI was apparently alone at the time of his visit and made no indication as to where he was going.

3. In view of the foregoing it is felt that little can be done at this point. Mrs. BOWEN was advised however, that if she did hear from GROSSI, she was to contact this office. Mrs. BOWEN also informed that she would be moving from KINGSTON in the very near future.

4. A copy of this report is being sent directly to the C.O. "A" Division for information. Unless further information is received this file will be noted as hereunder.
