NOTE:

This concerns the most recent of bombings which may be attributed to the anti-Castro Cuban power group led by Orlando Bosch in Miami. The "SS Coromoto" was three miles at sea when the explosion occurred and seawater would have flushed through the ballast tanks which were severely damaged by the force of the explosion. It is highly improbable that Laboratory examination on the scene would be productive.

We are instructing San Juan to cover dry-docking operations which are scheduled for 9/16/68 and Miami to intensify other phases of this bombing in order to either associate it with others or to develop evidence which will support criminal prosecution.

This was coordinated with the Laboratory Division.
