His date of birth is listed as March 17, 1934, In Arlington Heights. Ohio. His wife's name is given as LENNA, and his Faculty Advisor in 1959 was listed as LELAND JACOBS.

According to Miss PACKER, the subject is a candidate for a Doctor of Education degree specializing in Psychology (measurement) and is a student in good standing at this time.

The files of Immigration and Naturalization Service (INS), at New York City, reflect that on June 8, 1967, the subject's wife telephonically advised INS that both she and her husband would not consent to any interview by any member of that service.
