Re Milwaukee airtels to the Bureau dated 6/3/64, 6/12/64, and 7/17/64.

PCI [redacted] who is a close associate of THOMAS SIMONE, Top Hoodlum figure in the Kansas City Division, advised on 7/21/64, that during a recent conversation with SIMONE in which he invited SIMONE to spend a few days in the Las Vegas, Nevada area playing golf on or about 8/1/64, SIMONE refused this offer. SIMONE advised [redacted] that he would like to accompany [redacted] on this trip, however, due to a business engagement in Chicago, Illinois, during the pertinent period, he will be unable to do so. [redacted] had no further information pertaining to the purpose or nature of SIMONE's proposed trip. In view of caution statements placed in referenced airtels, no information is being furnished to informants and PCIs concerning proposed meeting on 8/2/64, or proposed travel by criminal figures in the Kansas City area other than in a most general nature.

In view of the above information, the Chicago Division is requested to advise whether the location of proposed meeting is SAM BATTAGLIA's stock farm in Hampshire, Illinois. Chicago is likewise requested to advise coverage desired on those individuals who most likely would travel to such a meeting. It is believed by this Office, that full surveillances of individuals most likely to attend such meetings in this area would not be feasible since such might expose Bureau interest.
