It is noted that this investigation is based upon receipt of information from the State Department during March, 1954, to the effect that one John D. McCormick, who was then residing in Mexico City, and who was presumed to be an American, had offered his services to President, Jose Figueres of Costa Rica in connection with an alleged revolutionary plot against Figueres. The facts in this case were presented to the Criminal Division for their opinion as to whether or not there was a potential violation of the Neutrality statutes under which the Bureau has jurisdiction. The Criminal Division subsequently advised that, while there was no logical basis to conduct an investigation from the standpoint of neutrality laws, an investigation should be undertaken to determine whether the subject's activities constituted a violation of the Foreign Agents Registration Act of 1938, as amended.

Rebulet instructed the Legat, Mexico City, to initiate an appropriate investigation in line with the Criminal Division's request, and a lead was set out for the WFO to check passport and visa files of the State Department for pertinent data concerning McCormick.

There is attached hereto for the WFO a copy of a cablegram dated 6-11-54 from the Legat, Mexico City, which reflects that McCormick is identical with Edward Browder, Jr., FBI No. 4 840 823, and further that the subject is presently in the custody of Mexican authorities on a bad check charge. Copies of Browder's identification record were forwarded to the Legat, Mexico City, on 6-14-54 by air mail. A copy of this record is attached hereto for the information of the WFO.

For the further information of the WFO, Bureau files disclosed that Browder was born on 6-22-17, at Amarillo, Texas. He received a Bachelor of Science Degree in Aeronautic Engineering from the University of Texas and also attended the Boeing School of Aeronautics and the Royal Military College, Sandhurst, England, for one and one-half years.
