IMMIGRATION LOCKUP. IT IS BELIEVED UNLIKELY HE WILL TRY TO
REACH U.S. BUT WILL PROBABLY ENDEAVOR TO PROCEED OVERLAND TO
NICARAGUA OR OTHER CENTRAL AMERICAN DESTINATION. MEXICAN
IMMIGRATION AUTHORITIES ACTIVELY SEEKING HIS APPREHENSION.
WILL ADVISE DEVELOPMENTS.
