EDWARD BROWDER JR, WAS, REGISTRATION ACT. RMYLET [NOVEMBER 26] (c)  
LAST. SUBJECT ARRESTED MEXICO CITY BY GOVERNACION POLICE  
[NOVEMBER 28] LAST ON BASIS INFORMATION FURNISHED THEM BY THIS (c)  
OFFICE RE WHEREABOUTS. THIS OFFICE DID NOT SUGGEST APPREHENSION.  
SUBJECT CLAIMS HE PILOTED P-47 FOR CASTILLO ARMAS REVOLUTION IN  
GUATEMALA AND THAT ARMAS OWES HIM SUBSTANTIAL SUM OF MONEY FOR  
SERVICES. HE IS COMPLETELY DESTITUTE AND HAS REQUESTED THAT  
MEXICAN AUTHORITIES DEPORT HIM TO GUATEMALA RATHER THAN UNITED  
STATES. DISPOSITION OF CASE BY MEXICAN AUTHORITIES UNCERTAIN  
SINCE NO PROCESS OUTSTANDING AGAINST SUBJECT IN US. WILL  
ADVISE.
