GUS ALEX, AKA., AR, DAILY SUMMARY. CORPORAL RON BROWN, RCMP, FORT WILLIAM, CANADA, ADVISED HE HAD DETERMINED THAT GUS ALEX WHILE AT THE BALL LAKE LODGE HAD MADE A PHONE CALL TO ONE HARRY HOLLEY, TELEPHONE NUMBER PI EIGHT DASH ZERO NINE THREE NINE, CHICAGO, ILLINOIS. THE CALL WAS BILLED TO THE LODGE AND WAS PAID FOR BY ALEX ALONG WITH HIS ACCOUNT WHEN HE LEFT. BROWN STATES BARNEY LAMM-S BALL LAKE LODGE IS PROBABLY THE BEST IN THE KENORA, CANADA AREA WITH RATES AROUND FORTY DOLLARS PER DAY AND LAMM IS AN AMERICAN FROM AROUND DETROIT LAKES, MINNESOTA, WHO HAS NOW BECOME A NATURALIZED CANADIAN. BROWN STATES LAMM HAS COOPERATED WITH HIM IN PAST AND BELIEVES LAMM AND STAFF OF THE HIGHEST ORDER. BROWN STATED THERE APPEARED TO BE NO REASON FOR INSTANT TRIP BY ALEX AND HIS ASSOCIATES TO BALL LAKE EXCEPT TO ENGAGE IN FISHING AND RELAXATION. BROWN ESTIMATED BILL FOR ALEX AND ASSOCIATES AT APPROXIMATELY THREE HUNDRED DOLLARS ON INDIVIDUAL BASIS BUT WAS UNABLE TO DETERMINE HOW BILL WAS PAID. BROWN COULD FURNISH NO INFORMATION REGARDING AN INDIVIDUAL IN ALEX-GROUP HAVING BEEN CALLED QUOTE RIP UNQUOTE. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES
