GUS ALEX, AKA. AR. DAILY SUMMARY. CONCERNING INFORMATION PREVIOUSLY REPORTED THAT SAM TAYLOR, BROTHER OF GUS ALEX, IS KNOWN BY NICKNAME "RIP," CG 6443-C HAS ADVISED THAT THE ONLY INDIVIDUAL KNOWN TO HIM AS "RIP" IS AN INDIVIDUAL WHO USED TO HANG OUT AT JIMMIE ALLEGRETTI'S PLACE AT THE BERKSHIRE HOTEL, CHICAGO, AND WHO IS A COLLECTOR FOR CHARLIE HUDSON, ASSOCIATE OF ALEX, AT THE HOLIDAY LOUNGE OR KITTEN LOUNGE, ON SOUTH STATE STREET, CHICAGO. CG 6445-PC ADVISED SEPTEMBER 20 LAST, HOWEVER, HE HAS KNOWN SAM TAYLOR TO BE REFERRED TO AS "RIP" FOR MANY YEARS. CG 6450-C\* ADVISED ALEX WAS PICKED UP NEAR HIS RESIDENCE THIS DATE BY NATHAN LADON AND TAKEN TO APEX AMUSEMENT CO., WHERE HE IS REPORTEDLY EMPLOYED BY EDWARD VOGEL, INTERESTING TO NOTE THAT IN 1954, A TRUST AGREEMENT RELATING TO PROPERTY ON WHICH THE FORT, A LARGE GAMBLING JOINT WAS LOCATED IN GLENVIEW, ILL., REFLECT<sup>ED</sup> LADON BENEFICIARY TO THIS PROPERTY. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
