ADVISED HE RECENTLY LEARNED THAT NICK ^{BRAVOS} AND GEORGE ^{BRAVOS}, CLOSE ASSOCIATES OF GUS ALEX, HAD ATTEMPTED TO SELL A BUSINESS ENTERPRISE CALLED HYDRO-THERM GAS COMPANY TO LESLIE KRUSE A FEW YEARS AGO FOR ONE HUNDRED THOUSAND DOLLARS. INFORMANT SAID AT THAT TIME THE BRAVOS BROTHERS HAD A CONTRACT FOR INSTALLING PENTANE GAS HEATING UNITS IN A HOUSING PROJECT AT GLENVIEW NAVAL AIR STATION, GLENVIEW, ILLINOIS. HE SAID PENTANE GAS FURNISHED THE HOUSING PROJECT IN GLENVIEW WAS INFERIOR AND THE LINES BECAME CLOGGED BY THE LIQUID GAS CAUSING A GREAT DEAL OF TROUBLE IN THE PROJECT AND THE NORTHERN ILLINOIS GAS COMPANY NOW HAS CONTRACT FOR PROJECT. INFORMANT SAID BRAVOS BROTHERS EMPLOYED ONE NICK ALEX, FIRST COUSIN OF GUS ALEX, AS FOREMAN OF HYDRO-THERM. HE ADVISED NICK ALEX FORMERLY OWNED THE LAKESIDE RESTAURANT WHICH WAS LOCATED ON BRYN MAWR AVENUE, CHICAGO, ^{TLL} AND IN ADDITION HE FORMERLY OWNED THE ELEVEN ELEVEN CLUB ALSO LOCATED ON BRYN MAWR AVENUE AND NOW NO LONGER IN EXISTENCE. INFORMANT STATED TO HIS KNOWLEDGE NICK ALEX IS NOT ENGAGED IN THE RACKETS AND WAS OBTAINING ABOUT ONE HUNDRED DOLLARS A WEEK FOR HIS EMPLOYMENT WITH HYDRO-THERM GAS COMPANY. INFORMANT FURTHER STATED THAT GUS ALEX WAS A PARTNER OF THE BRAVOS BROTHERS IN THE PENTANE GAS COMPANY. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
