GUS ALEX, AKA., AR. DAILY SUMMARY. CG SIX FOUR FOUR THREE DASH C ADVISED HE HAD LEARNED RECENTLY THAT IN ADDITION TO KAPLAN-S AUTO PARKING GARAGE AT WABASH AND RANDOLPH STREETS, GUS ALEX REPORTEDLY HAS AN INTEREST IN TWO OTHER PARKING LOTS IN THE LOOP AREA OF CHICAGO. INFORMANT SAID ONE OF THESE PARKING LOTS IS LOCATED ON MONROE STREET ACROSS FROM THE SCHUBERT THEATER AND THE OTHER IS LOCATED ON THE NORTH-EAST CORNER OF WABASH AND VAN BUREN STREETS. INVESTIGATION REFLECTS THE PARKING LOTS MENTIONED ABOVE ARE DEE DASH EL GARAGE, INC., TWO NINE WEST MONROE STREET, AND TOWN PARKING STATIONS, INC., FOUR ZERO ONE SOUTH WABASH STREET.
