GREECE EARLIER THIS YEAR THEY VISITED WITH CONTOS. INFORMANT SAID

CONTOS HAD NO STATUS IN THE GAMBLING OR VICE UNDERWORLD IN CHICAGO WHEN

HERE OTHER THAN BEING A CARD DEALER OR SHILL IN CRAP GAMES. INFORMANT

SAID THESE JOBS WERE SECURED FOR CONTOS BY ALEX AND THAT CONTOS HAD

BEEN WORKING AS A CARD DEALER IN THE CHICAGO AREA FOR ABOUT TWENTY

YEARS PRIOR TO LEAVING THE COUNTRY. PCI SAID CONTOS DID NOT HAVE THE

INTELLIGENCE TO BE ENTRUSTED WITH ANY JOB OF IMPORTANCE FOR ALEX.

ALEX SHOULD BE CONSIDERED ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
