GUS ALEX, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED THAT HE HAD RECENTLY BEEN IN THE COMPANY OF LOUIS ARGER, LIEUTENANT OF ALEX, AND ARGER REQUESTED INFORMANT TO MAKE THE FIRST OF THE MONTH COLLECTIONS FOR NOVEMBER FROM VARIOUS SOUTH STATE STREET STRIP JOINTS IN CHICAGO'S FIRST WARD, WHICH WOULD LATER BE PAID TO PAT MARCI, SECRETARY OF FIRST WARD ALDERMAN JOHN D'ARCO, AS A TRIBUTE TO THE MARCI ORGANIZATION FOR POLICE FIXES AND OTHER FAVORS BESTOWED UPON THE STRIP JOINTS. INFORMANT SAID THIS COLLECTION WAS TAKEN AT THE KITTEN LOUNGE. HE SAID REPRESENTATIVES FROM EDDIE FOYS, CABANA LOUNGE, CROSSROADS, TOWN CASINO, MOULIN ROUGE, 606 CLUB, HOLIDAY LOUNGE, KITTEN LOUNGE AND THE CAFE PARISIAN FURNISHED THEIR CONTRIBUTIONS IN ENVELOPES TO HIM AND ARGER TOLD HIM THAT EACH CLUB WAS ASSESSED \$300 PER MONTH. INFORMANT SAID ARGER THEN REQUESTED HIM TO TAKE THE ENVELOPES TO MARCI'S OFFICE, WHICH HE DID. INFORMANT FURTHER ADVISED THAT ARGER TOLD HIM THAT THE OWNERS OF THESE STRIP JOINTS ALSO HAVE TO CONTRIBUTE A CERTAIN PERCENTAGE OF THEIR NET PROFITS TO THE OUTFIT EACH MONTH AND THAT THIS AMOUNT IS PAYABLE BY THE OWNERS ON THE THIRD DAY OF EACH MONTH. INFORMANT SAID THAT ARGER TOLD HIM THAT THIS WAS GENERALLY DELIVERED EITHER DIRECTLY TO MARCI'S OFFICE OR TO POSTS GYMNASIUM AND THAT ALEX IS USUALLY AT ONE OF THESE LOCATIONS WHEN THE MONTHLY PAYMENT IS MADE. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
