INFORMANT STATED THAT THE FOLLOWING PER CENT OF PROFITS IS PAID BY THE FOLLOWING PERSONS FOR THE FOLLOWING PLACES OF BUSINESS: MOULIN ROUGE, PAYMENT MADE BY GEORGE HOBSON, 50 PER CENT OF PROFITS. CABANA CLUB, PAYMENT BY MIKE ELLIS, 50 PER CENT OF PROFITS. TOWN CASINO, PAID BY PEEP LORDO, 50 PER CENT OF PROFITS. EDDIE FOY'S, PAID BY TONY TORNABENE, 50 PER CENT OF PROFITS. THE CROSSROADS, PAID BY BILL FISHMAN, 30 PER CENT OF PROFITS. SIX HUNDRED SIX CLUB, PAID BY BILL GOLDMAN, 50 PER CENT OF PROFITS. CAFE PARISIAN, PAID BY GEORGE HOBSON OR CHAPPIE BERTUCCI, 30 PER CENT OF PROFITS. KITTEN LOUNGE AND HOLIDAY LOUNGE, PAID BY LOUIS ARGER, 20 PER CENT OF PROFITS. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
