GUS ALEX, AKA, AR. DAILY SUMMARY. CG SIX FOUR FOUR THREE DASH  
 THAT HE HAD LEARNED FROM LESLIE KRUSE, CLOSE ASSOCIATE OF ALEX, THAT  
 GAMBLING IS PRESENTLY CURTAILED IN BOTH THE CITIES AND COUNTIES  
 SURROUNDING CHICAGO. INFORMANT SAID THAT ANY OPERATIONS IN CONNECTION  
 WITH GAMBLING GOING ON AT THE PRESENT TIME ARE SMALL AND ARE OPERATED  
 ON A QUOTE SNEAK BASIS UNQUOTE. THE ONLY OPERATION TO INFORMANT-S  
 KNOWLEDGE IN SO FAR AS BOOKING HORSES GOING ON AT THE PRESENT TIME  
 WAS THE HILLTOP LOUNGE LOCATED ON THE FAR SOUTH SIDE OF CHICAGO AND IT IS  
 OPERATED BY TWO BROTHERS, PETE AND SAM, LAST NAME UNKNOWN TO INFORMANT.  
 HE SAID THIS PLACE IS OPEN BETWEEN ELEVEN A. M. AND TWO P. M. AND THAT  
 THE BETS ARE WRITTEN ON SLIPS. INFORMANT STATED THAT TELEPHONES ARE  
 NOT BEING USED TO TRANSMIT RACING INFORMATION. INFORMANT SAID BENTLEY  
 MURRAY OF THE BENTLEY MURRAY COMPANY HAS STOPPED PRINTING QUOTE HARD  
 CARDS UNQUOTE AND OTHER GAMBLING INFORMATION AND BELIEVED THAT THE  
 COMPANY WAS NOW OUT OF BUSINESS. HE SAID THIS IS A RESULT OF THE NEW  
 FEDERAL LEGISLATION THAT WAS RECENTLY ENACTED. INFORMANT SAID THAT ALL  
 GAMBLERS IN CHICAGO AND VICINITIES ARE EXTREMELY CAREFUL ABOUT DOING  
 BUSINESS ACROSS STATE LINES. INFORMATION HAS PREVIOUSLY BEEN RECEIVED  
 FROM OTHER SOURCES THAT ALEX AND HIS ASSOCIATES ARE GREATLY CONCERNED
