GUS ALEX, AKA. AR - DAILY SUMMARY. CG 6443-C ADVISED THAT ALEX WAS VERY DISPLEASED WITH LOUIS ARGER AS A RESULT OF NEWSPAPER ARTICLES REGARDING THE SOUTH STATE STREET STRIP JOINTS WHICH LINKED ARGER'S NAME TO GUS ALEX IN THE NEWSPAPERS. INFORMANT STATED THAT ARGER IS OBVIOUSLY WORRIED OVER ALEX'S DISPLEASURE WITH THIS ENTIRE SITUATION. ARGER IS CURRENTLY OWNER OF THE KITTEN LOUNGE, HOLIDAY LOUNGE, AND CAFE PARISIAN REVUE, ALL STRIP JOINTS WHICH ESTABLISHMENTS ARE CURRENTLY CLOSED UNTIL AFTER CHRISTMAS. INFORMANT HAS PREVIOUSLY ADVISED THAT ALEX DERIVES INCOME FROM THESE JOINTS. INFORMANT FURTHER ADVISED THAT BEN STEIN ALSO IS IN DISFAVOR WITH ALEX BECAUSE OF THE PRESENT GRAND JURY INVESTIGATION OF THE NATIONAL MAINTENANCE CORPORATION OF WHICH STEIN IS PART OWNER. ARGER WAS FORMER EMPLOYEE OF NATIONAL MAINTENANCE CORPORATION. INFORMANT SAID THAT STEIN CONTINUES TO MAINTAIN THAT ALEX IS A FRIEND OF HIS WHEN INTERVIEWED BY NEWSPAPER REPORTERS. BECAUSE OF THE INVESTIGATION, INFORMANT SAID THAT NOBODY IN THE "OUTFIT" WANTS ANYTHING TO DO WITH STEIN. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
