GUS ALEX, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED HE HAD RECENTLY BEEN IN THE COMPANY OF LESLIE KRUSE, ASSOCIATE OF ALEX, AND THAT THEY HAD MADE A TRIP IN THE CHICAGO SUBURBAN AREAS WHERE THEY WERE MAKING A SURVEY FOR A NEW GAMBLING SPOT SIMILAR TO THE J AND J PICNIC GROVE WHICH HAD RECENTLY BEEN SHUT DOWN. INFORMANT ADVISED KRUSE IS MOST ANXIOUS TO GET STARTED AGAIN EVEN IF IT HAS TO BE ON SMALL SCALE AS ALL OF HIS EMPLOYEES, INCLUDING GUS LIEBE, ARE PRESENTLY LAID OFF AND IF THE DEALERS AND DICE MEN DO NOT BECOME EMPLOYED IN THE NEAR FUTURE THEY WILL MOVE WEST AND ANY FUTURE GAMBLING OPERATIONS WOULD BE IMPOSSIBLE WITHOUT THE PROPER HELP. INFORMANT STATED THAT KRUSE VISITED A SMALL ABANDONED GAS STATION WHICH WOULD BE BIG ENOUGH TO HANDLE A GOOD SIZE CRAP GAME AND OTHER SMALL GAMBLING GAMES AND THIS GAS STATION IS LOCATED IN THE TOWN OF LILLYMOOR IN MC HENRY COUNTY, JUST OFF ROUTE 12 ON LILLY LAKE. INFORMANT STATED KRUSE BELIEVES THIS TO BE ONE OF THE PRIME PLACES TO OPEN A BIG GAMBLING OPERATION IF THE UPPER ECHELON OF THE "OUTFIT," INCLUDING GUS ALEX, DECIDES TO REINSTITUTE A GAMBLING OPERATION. INFORMANT SAID KRUSE STATED IT WOULD ONLY TAKE ABOUT \$2,000 TO RENOVATE THIS SPOT AND IF IT IS KNOCKED OFF, THERE WOULD BE NO LARGE INVESTMENT LOSS. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
