GUS ALEX, AKA, AR, DAILY SUMMARY. YOU HAVE BEEN ADVISED THAT CG 6443-C AND CG 6498-PC HAVE FURNISHED INFORMATION CONCERNING THE RELATIONSHIP WHICH EXISTS BETWEEN GUS ALEX AND SAM SAMARAS AND ANDY FASSEAS. FASSEAS WAS CHIEF OF THE REVENUE DEPARTMENT OF THE STATE OF ILLINOIS UNDER GOVERNOR STRATTON UNTIL A YEAR AGO, AND SAMARAS WAS HIS CHIEF INVESTIGATOR. CG 6443-C RECENTLY ADVISED THAT SAMARAS WAS THE INDIVIDUAL CONTACTED BY ALEX AND HIS SUBORDINATES, LOUIS ARGER AND LOUIS TORNABENI, WHO, TWO YEARS AGO, WERE IN DIFFICULTY DUE TO THE FACT THAT THEY DID NOT PAY THE PROPER AMOUNT OF SALES TAX IN CONNECTION WITH THEIR OPERATION OF STRIP AND CLIP JOINTS IN CHICAGO LOOP AREA.
