GUS ALEX, AKA. AR. DAILY SUMMARY. CG 6502-C* ADVISED THAT ALEX WAS IN CONFERENCE WITH AN UNKNOWN PERSON IN HIS APARTMENT ON JANUARY 25 LAST. THIS UNKNOWN PERSON WAS COMPLAINING TO ALEX THAT THE SHERIFF AND STATES ATTORNEY'S OFFICES ARE MAKING ALL KINDS OF ARRESTS AND THAT THEY HAVE EVERYONE SNITCHING ON EACH OTHER. THIS PERSON STATED THAT THEY ARE HITTING GAMBLING AND LOOKING AT IT FROM ALL ANGLES. HE MENTIONED TO ALEX THAT THERE ARE ABOUT 45 \$250 GAMBLING STAMPS ISSUED IN THE CHICAGO AREA AND THE LIQUOR COMMISSION IS GOING TO CALL THEM ALL IN AND HAVE THEM SHOW CAUSE WHY THEIR LICENSES SHOULD NOT BE REVOKED. HE TOLD ALEX HE WAS GOING TO QUIT BECAUSE "THE DOOR IS NOT OPEN ANY PLACE." ALEX SAID HE WOULD LOOK INTO THE MATTER AND TOLD THE PERSON TO CALL "KLUTZ" AT THE BARBER SHOP. IN REGARD TO KLUTZ, CG 6272-C ADVISED THAT SEVERAL MONTHS AGO KLUTZ WAS ONE OF ALEX' TOP GAMBLING LIEUTENANTS UNDER LOUIS BRIATTA. AS SUCH KLUTZ WAS IN CHARGE OF ALL THE INDIVIDUAL BOOKMAKERS IN ALEX' DISTRICT AND ALSO MADE COLLECTIONS FROM THEM. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
