GUS ALEX, AKA., AR. DAILY SUMMARY.

ALEX HELD GOING AWAY PARTY FOR SUZANNE FUEGER, NOVEMBER 21, LAST, ATTENDED BY EDWARD VOGEL, BUTCH LADON, HENRY SUSK AND VOGEL'S GIRL FRIEND PEGGY STRAK. BESIDES DISCUSSION OF INTRICACIES OF LALEX'S DOOR ALARM WHICH IS CONCERN OF HIS SINCE HE ALSO IS PLANNING TO LEAVE SOON ON EXTENDED VACATION. ALEX DESCRIBED A RECENT INCIDENT TAKING PLACE IN HIS BUILDING. APPARENTLY TWO UNKNOWN MALES ENTERED BUILDING AND ATTEMPTED TO GAIN ACCESS TO THE BASEMENT. DOORMAN, WHO IS A CONFIDANT OF ALEX, FAITHFULLY REPORTED TO HIM ANY UNUSUALLY ACTIVITY, APPARENTLY NOTICED UNKNOWN MALES AND IS ABLE TO IDENTIFY THEM.

ALEX STATED "THEY WANTED TO BUG THIS APTMENT." SUSK SUGGESTED ALEX CHECK ON THIS SINCE "THEY MAY HAVE THE GUY UPSTAIRS. THEY DON'T HAVE TO GO THROUGH THE DOOR TO BUG IT." ALEX EXPRESSED GREAT CONCERN AS TO WHY THEY TOOK A PICTURE OF LOCK AND BUILDING MANAGER WANTED TO SEE HIM RE THIS MATTER.

BUILDING MANAGER IS PCI AND COMPLETELY COOPERATIVE BUT NOW UNAVAILABLE.

CHICAGO WILL DISCREETLY DETERMINE FROM PCI IF ALEX HAS CAUSE FOR CONCERN THIS MATTER.

CHICAGO UNAWARE IDENTITY ABOVE UNKNOWN MALES BUT BUREAU MAY RECALL RECENT ATTEMPT BY CHICAGO POLICE DEPARTMENT TO GAIN ENTRANCE TO APARTMENT OF MURRAY HUMPHREYS.
