MIAMI REQUESTED TO DISCONTINUE EFFORTS TO LOCATE ALEX, HOWEVER, SHOULD THROUGH LOGICAL SOURCES ATTEMPT TO DETERMINE ALEX'S ACTIVITIES WHILE IN MIAMI AREA.
