Chicago advises Alex is continuing efforts to obtain lifting of ban against his re-entry into Switzerland. Chicago attorney George Bieber, who has been closely associated with hoodlum figures, reported to be assisting Alex in this regard.

Legat should be alert to further developments in this situation and should keep the Bureau advised of any information of interest; however, in view of controversial aspects of situation, it is not desired that Legat make any active inquiries at this time.

Note: Alex was barred by Swiss authorities in 1965 from re-entering Switzerland for a period of 10 years due to his unsavory background and reputation as a hoodlum. He has continued efforts through attorneys to have this ban lifted and within the recent past, letters were forwarded to Swiss authorities by Congressman Dawson and Senator Dirksen, both of Illinois, in Alex's behalf.

Chicago has indicated efforts to lift the ban are being continued by Alex and his attorney George Bieber, and has suggested contact of Swiss officials by Legat regarding ban against Alex. Recent information indicates the ban still in effect and representative of Swiss authorities, after checking into the matter in Chicago, indicated he would recommend continuance of ban. In view of controversial aspects of this situation, and prominence of several individuals mentioned in connection therewith, it is not considered desirable for Legat to make inquiries of Swiss authorities at this time and he is being so advised.

AS BUREAU IS AWARE, ALEX HAS BEEN BARRED FROM ENTRY INTO SWITZERLAND BY SWISS GOVERNMENT.

CG SIX FIVE EIGHT C TE ADVISED SEPTEMBER TWENTY THAT ON SEPTEMBER SEVENTEEN ALEX INSTRUCTED CHICAGO HOODLUM ATTORNEY GEORGE BIEBER TO MAKE ARRANGEMENT SO THAT HE COULD AGAIN ENTER SWITZERLAND. BIEBER THEREUPON CONTACTED UNKNOWN OFFICIAL, APPARENTLY IN SWISS CONSULATE IN CHICAGO. ALEX, BIEBER AND THIS OFFICIAL THEN MET IN BIEBER'S OFFICE SEPTEMBER EIGHTEEN LAST. AT THIS TIME OFFICIAL TELEPHONICALLY CONTACTED ANOTHER OFFICIAL, POSSIBLY IN WASHINGTON, D.C., IN THIS REGARD.

INFORMANT UNABLE TO FURNISH ANY FURTHER DETAILS. BUREAU REQUESTED TO CONSIDER CONTACT OF SWISS OFFICIALS BY APPROPRIATE LEGAT RE STATUS OF INTERDICTION ORDER AGAINST ALEX, NOTED THIS SITUATION RECENTLY PUBLICIZED IN CHICAGO PRESS.
