REMYTEL JUNE SEVEN LAST ADVISING ALEX LEFT CHICAGO FOR EUROPEAN TRIP.

[CHICAGO SIX SIX FIVE EIGHT - CTE]<sup>(S)</sup> ADVISED ALEX RETURNED TO CHICAGO JULY TWENTY THREE LAST AND IMMEDIATELY CALLED FELIX "MILWAUKEE PHIL" ALDERISIO. CTE ADVISED HE BELIEVES CALL PERTAINED TO ALDERISIO'S SHAKEDOWN OF GEORGE BIEBER. NOTED THAT BIEBER HAS PAID ALDERISIO TOTAL OF SOME FORTY THOUSAND DOLLARS ON ALDERISIO'S ASSURANCE HE WILL INSURE AGAINST INDICTMENT OF BIEBER IN USDC. BIEBER HAS CONSTANTLY COMPLAINED TO ALDERISIO RE THIS AND TOLD HIM HE WOULD IMMEDIATELY SO INFORM ALEX UPON HIS RETURN. CTE STATED ALEX VERY CURT WITH ALDERISIO UPON HIS CALL BUT CTE UNABLE TO OBTAIN FROM ALDERISIO EXACT DETAILS OF ALEX' CALL.
