departure that he intended to travel to Spain. (The Spanish National Police in Madrid, Spain was alerted on June 11, 1968, regarding ALEX's purposed visit to Spain and data concerning the background of ALEX was furnished to them. However, at no time was the Spanish Mational Police able to develop any information indicating that ALEX was in Spain during June and July, 1968.

IV. MISCELLANEOUS

CG T-1 advised that one of the first items of business of ALEX upon his return to Chicago on July 23, 1968, was to arbitrate differences which had arisen during his absence between Chicago attorney GEORGE BIEBER and ALEX's associate in organized crime, FEEIX "Milwaukee Phil" ALDERISIO. The informant noted that BIEBER fears that he is about to be prosecuted by the United States Attorney's Office and that ALDERISIO in return for a monetary consideration guaranteed to BIEBER that he would not be prosecuted. The informant was unable to furnish any information or further details indicating the methods to be employed by ALDERISIO in his protection of BIEBER in this regard.

Information has been received from the Swiss Federal Aliens Police on July 9, 1968, that ALEX's appeal for a revocation of the WSwiss Entry Ban against him had recently been denied and that ALEX had no further recourse to have this ban canceled. It is noted that the Swiss Government banned ALEX from entry of Switzerland for ten years approximately three years ago. Since that time ALEX has made several efforts to have this entry ban against him lifted.
