From the technical standpoint only, it does not appear from the data furnished in referenced airtel that the Radio Frequency Microphone - Telephone Units (RFMTU) could be used to energize subject's telephone instrument. If further inquiry develops that it would be possible to break both sides of subject's telephone line for the purpose of inserting radio frequency chokes between the monitoring point and the central office, you should submit telephone cable blueprints covering the pertinent area to the Laboratory in order that a more detailed study can be conducted. In the event this is done, you should also set forth information as to the location of the possible monitoring plant including the distances that the wires will have to run between the monitoring plant and the instrument to be energized.

Above information relates strictly to the technical aspect of your question: From the standpoint of Bureau authority to use this device, you are advised that its use has been confined to top Internal Security and Espionage cases in the past. Also in these cases it is noted that a straightforward microphone installation was not possible. Accordingly, from the standpoint of possible authorization, any Internal Security activities developed in connection with this case would be pertinent.

GIANCANA is generally considered the number one man in the Chicago organized criminal element. He is one of ten nation-wide hoodlums under intensification, investigation by the FBI and the IRS. In this capacity as chief he has as his command post the Armory Lounge, (AL) 7427 West Roosevelt Road, Forest Park, Illinois, the Western Chicago suburb. Informants report he meets in a private room in the rear of the AL where he receives appointments, gives orders, formulates policy and generally oversees criminal activities, which he is responsible for. He reportedly is at the AL only on a daily basis when he is in Chicago. (U)

The following survey was conducted by Sound Agent LLOYD H. NELSON through cooperation of the local telephone company contact. (U)

The AL is situated on the northwest corner of Roosevelt Road (US 30 east-west) and Thomas Street. The building itself fronts on busy and well lighted Roosevelt Road. A parking lot is located on the west side of the building which is a one story brick structure which

is 24 ft. in width and 60 ft. in depth. West of the parking lot a total distance from the AL of approximately 60 ft. is situated three apartment buildings that extend westward to the next street. These apartment buildings like the AL front on Roosevelt Road facing south. To the rear of the AL and the apartment buildings is an alleyway that parallels Roosevelt Road along side of which runs an aerial telephone cable feeding the buildings primarily facing south along Roosevelt Road. (U)

Directly to the rear of the AL is a telephone pole which mounts a terminal box that feeds the three telephone instruments in the AL. One of these telephones is a coin phone and the others are a WC set number 554 (Western Electric) and its extension an HC set number 306. The latter instrument is situated in the room occupied by GIANCANA, which measures approximately 14 X 16 ft. (U)

The only multiple of the number 306HC set within 1,000 ft. of the AL is situated in a terminal box mounted on the pole at the rear of 1135 Ferdinand Street. This pole is approximately 800 ft. distant. From an examination of the buildings in the area covered by the multiple appearance it would appear that the residence of 1135 Ferdinand Street is best suited for monitoring purposes. No contact has been made at this residence at this time. (U)

Neither Sound Agent NELSON or Sound Agent PETER P. SCHNEIDER both of whom had some work relative to the establishment or attempted establishment of RFMT Units approximately nine years ago can recall the limitations and requirements for a successful installation of such a unit. (U)

The Laboratory therefore is being requested to advise as soon as possible if a RFMT Unit could be utilized in the situation referred to above. (U)
