RE CG 6468-C*. IT IS NOTED IN YESTERDAY'S SUMMARY RE-ENTRY WAS MADE AND MITE UNIT INSTALLED. SUBSEQUENT INVESTIGATION REVEALED THAT REMODELING PROCESS RESULTED IN COMPLETE REWIRING OF LOCATION, INCLUDING REROUTING OF TELEPHONE CABLING. TELEPHONE FRAME PREVIOUSLY UTILIZED NO LONGER IN OPERATION AND IT APPEARS THAT IN ORDER TO ACTIVATE SOURCE IT IS NECESSARY TO RE-ENTER LOCATION SO THAT UNIT MAY BE ACTIVATED FROM WITHIN RATHER THAN ATTRACT EXPOSURE BY WORKING FROM OUTSIDE OF BUILDING. DAILY SUMMARY. RE ARMORY LOUNGE AND RE INSTALLATION OF CG 6486-C*. ENTRY MADE INSTANT, ONE MITE UNIT INSTALLED, NOT YET OPERATIVE DUE TO MECHANICAL PROBLEMS NOT PRESENT AT TIME OF ORIGINAL INSTALLATION. REMODELLING PROCESS AT SITE CHANGED TELEPHONE WIRING SYSTEM. ORIGINAL MEETING ROOM NOW A STORAGE ROOM CONTAINING LINENS, MEAT LOCKER, DEEP FREZE, ETC. SURVEY INDICATES GIANCANA, ET AL, PROBABLY MEET AT REAR OF DINING ROOM WHERE LARGE BOOTH IS SET UP WITH TELEPHONE EXTENSIONS. MITE COVERAGE SUITABLE FOR THIS SPOT AND REAR STORAGE ROOM. (U)

DURING PHYSICAL SURVEILLANCE PRIOR TO ENTRY, NUMEROUS CARS NOTED, AMONG THEM BLASI'S AND GIANCANA'S. INDIVIDUAL RESEMBLING GIANCANA OBSERVED APPARENTLY MAKING CLANDESTINE MEETING ON STREET, THEN SEEN ENTERING ARMORY CARRYING SMALL VALISE. (U)
