SCIARRA has a friend who has been making telephone calls from his home telephone number 401-274-1870. Informant believes that the individual calling from the SCIARRA telephone is some hoodlum from Boston or someone who is connected with the Boston LCN faction.

In August, 1973, T-1 advised that SCIARRA still hates CALLEI and desires his removal from the Providence, Rhode Island, hoodlum scene. SCIARRA is in the same section of the ACI as CALLEI and for this reason no attempts to murder CALLEI are to be made on SCIARRA's authority. SCIARRA indicated to T-1 that CALLEI will eventually be murdered. T-1 learned through sources at the ACI that SCIARRA is attempting to remove himself from the minimum section into the maximum security section where PRO LERNER is located. SCIARRA commented one time that everyone has deserted LERNER and he wants to continue as his friend and move over to the maximum security section where he could help LERNER do his "time." T-l advised that JERRY OUIMETTE is spending a considerable amount of time with CALLEI in the minimum security section of the ACI. T-1 was of the opinion that OUIMETTE might be the individual being used by SCIARRA to set up CALLEI in a prison killing. T-l pointed out the well-known fact that SCIARRA and CALLEI are at odds and that the prison officials are cognizant of the threats made by SCIARRA to remove CALLEI.

T-l further advised that apparently DANTE SCIARRA made the comment that the SCIARRAS have Silver Lake, NICK BIANCO has Federal Hill and EDDIE ROMANO has Charles Street, with regards to the control of gambling and illegal activity, DANTE SCIARRA, brother of RUDY, commented that the SCIARRAS, while they have Silver Lake, would rather have Thornton, which is the district functioning under the control of the CALLEI faction, with BABE PEZZO watching over CALLEI's interest in that location.

T-l advised that FRANK AMBROGLIA from Boston and FREDDIE BISHOP are in the SCIARRA camp and are in contact with DANTE SCIARRA and also LUCY SCIARRA.

T-l advised that LUCY SCIARRA has telephone number 274-1870, and uses it in contacting individuals from Boston for her husband. FREDDIE BISHOP is living with a girl by the name of JENNIFER.
