KORSHAK got ahold of him and he's telling him what to do." This is believed to refer to a luncheon engagement which took place on 2/25/63 which was attended by PCI Alderman D'ARCO, PAT HOY, and one or two other individuals, at which time HOY was instructed to see that persons involved in this situation employed at the Hilton Hotel did not make any comments to any investigators concerning the situation. Shortly thereafter ART PETAQUE joined MARCY and made arrangements to interview FIO RITO with the proviso that he would write a favorable story regarding him. It is pointed out that on 2/23/63 PETAQUE met with MARCY and made arrangements to write a story favorable to the First Ward situation and FIO RITO and was given a monetary gift despite his objections by MARCY.

Election Commissioner HOLTZMAN has ruled that to be eligible to be elected as an Alderman that the only residence requirement is that the individual elected reside in the Ward the day he is elected. From this ruling it is obvious that MARCY has misinterpreted the rule. All of this consternation with the papers has resulted from this misinterpretation, the net result obviously lowering MARCY's position with the hoodlums.
