A further discussion was held with MIKE ELLIS, who joined MARCY, concerning Detective MARVIN MANDEL of the Chicago Police Department. MANDEL has been previously identified to the Bureau as a 1st District vice detective who has caused considerable consternation because of the excellent investigative work being done in regard to vice activities within the Loop strip joints in which MARCY has an interest. MARCY gave ELLIS specific instructions to stay away from MANDEL and to issue instructions that no one is to attempt to pay MANDEL off. CHICAGO, ILL

On the 19th, MARCY attended the City Council meeting with Alderman MICHAEL FIO RITO. On this date, FIO RITO was sworn in as Alderman of the 1st Ward. It was noted that at this meeting, Alderman JOHN HOELLAN of Chicago's 47th Ward attempted to introduce a measure barring FIO RITO from sitting on the Council, stating that FIO RITO was not duly elected to the office because of irregularities in his residence. It was noted that Alderman THOMAS KEENE immediately moved to have HOELLAN quieted, and refused to allow HOELLAN to introduce his measure, stating that it was not a proper motion at that time. CHICAGO, ILL

On the 19th, MARCY, D'ARCO and FIO RITO held a discussion regarding a luncheon proposed by ANTHONY GIROLAMI, Clerk of the Probate Court, who has issued an invitation to FIO RITO to have luncheon with agents of the FBI who are known to these persons to be working on organized crime in the Chicago area. 211

It is pointed out that an informant of the Chicago Division, feels that FIO RITO might be inclined to sit with agents and discuss the situation within the 1st Ward. MARCY advised D'ARCO that he felt it was up to FIO RITO as to whether he desired to meet with the agents stating that "he knows when to shut them off if they start reaching out." D'ARCO also felt that it would be a good idea for FIO RITO to sit with the agents. As of this date, no decision has as yet been made as to whether FIO RITO will joint with the agents. OTHER 4

On 4/22/63, ANTHONY TISCI met with MARCY, at which time he advised that agents of the Chicago Division had
