Re my letter March 22, 1974.

MEX 34 advised April 8, 1974, that Cuernavaca telephone number 2-25-00 is installed at Quinta San Cristobal, the home of SAM DE PALMA. The housekeeper at that residence, a woman named JOSEFINA, said that the owner of the house as of that date was traveling in Europe. She indicated that he would be returning to Mexico for a short visit toward the end of May or the beginning of June, 1974. In the meantime, his attorney, CASTILLO, telephone 5-68-15-70, Mexico, D. F., was handling his affairs.

Source further advised 5-7-74, that subsequent pretext contact at this residence determined that the subject was not in residence and had not returned.

MEX 170 is attempting to obtain long distance telephone calls listed to the phone in Cuernavaca.

MEX 170 advised 4-2-74, that he could find no record of CAROLINE MORRIS at the Hotel Aristos, Mexico, D. F., Mexico, where subject's girl friend is alleged to have stayed when visiting in Mexico.

CS MEX 287 has been contacted on various occasions. He has had no personal contact with the subject and the last indirect information he had was that subject was in Mexico City as of 2-10-74.

Source last contacted 4-26-74, at which time he advised he had been in Cuernavaca over Easter and been in contact with a number of known associates of subject, and no mention was made of subject.

The Bureau got a copy of Drug Enforcement Administration memo 4-1-74, indicating that subject was living in Cuernavaca, etc. The reference to Can Can in the last paragraph is believed to refer to Cancun, a new resort under development in the territory Quintana Roo, Mexico. This is a development by the Mexican Government and it is not known what the MC GUIRE sisters might have to do with this development. **AU**

In addition, Drug Enforcement Administration Office, Mexico City, reported 5-8-74, information from an usually reliable source that subject was residing and spending some time in Oaxaca, Oaxaca, Mexico. Supposedly his attorney, JORGE CASTILLO, was associated with an Italian national, DINO MARIO CARDELLA-TURBIA, resident at Calle Amapola 203, Colonia Reforma, Oaxaca, owner of the "El Padrino" bar, Calzada Heroes de Chapultepec 822, Oaxaca, Oaxaca, Mexico. They considered that this might be identical to DINO CARDELLA, who has figured in narcotics investigations. **AU**
