On 6/25/74 Commander DAVE DILLEY, Organized Crime Section, New Scotland Yard (NSY), advised that their investigation established that LAUREN BACALL resides at 23 Chester Row, London, S.W. 1. \$ (u)

They have been unable to establish if in fact CAROLYN MORRIS and/or subject ever visited England. The Alien Registration Office records of the British Government contain no information indicating that these two persons ever were in the United Kingdom. NSY sources familiar with organized crime activities have been unable to supply any information regarding CAROLYN MORRIS and/or subject. \$ (u)

NSY established that the subscriber to telephone number 727-9952 in London is one S. WHIKE, of Six Moorehouse Road, London, W.2. It is an unlisted number, and this individual is not known to NSY. The subscriber to telephone number 629-0572 is E. H. MORRIS LTD. of 50 Bond Street, London, which is a company publishing music. \$ (u)
