ABOVE NUMBER IS LISTED TO QUINTA SAN CRISTOBAL, RESIDENCE OF SUB-  
JECT AT TIME HE WAS DETAINED AND DEPORTED ON JULY 18-19, 1974. ON  
SEPTEMBER 13, 1974, MEX 349 - PCI FURNISHED A LIST OF TOLL CALLS  
FROM MOST RECENT BILL PREPARED FOR THIS NUMBER. SOURCE DETERMINED  
PHONE STILL LISTED IN TELEPHONE COMPANY RECORDS TO FORMER OWNER,  
GERALD W. SCHULTZ (DECEASED), WHO HAS STATED HE SOLD THIS HOUSE TO  
SUBJECT IN ABOUT NOVEMBER, 1969. THE SOURCE SAID THAT DUE TO BILLING  
PRACTICES FOLLOWED BY THE TELEPHONE COMPANY IN CUERNAVACA, WHICH  
ARE APPARENTLY QUITE DISORGANIZED, IT WAS NOT POSSIBLE TO LOCATE A  
RECORD OF EARLIER TOLL CALLS CHARGED TO THIS NUMBER. SOURCE ALSO  
POINTED OUT THAT IT IS NOT UNCOMMON IN MEXICO FOR A NEW OWNER OR  
TENANT TO LEAVE THE TELEPHONE LISTING IN THE NAME OF THE FORMER  
SUBSCRIBER, AND THAT CONDITION OF RECORDS DID NOT PERMIT A DISTINCTION
