Enclosed herewith is a translation of a newspaper article concerning subject's deportation. (u)

Reference report of SA JOHN J. FOARDE, JR. dated 9/13/74 at Mexico City. (u)

Translation by Assistant Legal Attache RICHARD S. CLARK. Noted that this is the only known publicity given to this deportation. CS MEX 287 commented that this was remarkably little publicity considering the prominence of the subject. He speculated that the Mexican government, which is considered to have some degree of control over the Mexican press, did not want publicity concerning subject's presence in Mexico. (u)
