 TAMPA BY REGULAR ESTABLISHED SOURCES. TP FIFTY DASH PCI ADVISED
 NINE THIRTEEN SUBJECT WENT TO MIAMI AFTER LUCILLE TRAFFICANTE
 WEDDING, AUGUST TWO SEVEN, LAST, AS IT WAS AGREED HIS PRESENCE IN
 TAMPA WAS CAUSING TOO MUCH HEAT. SOURCE SAID AUGUSTINE PRIMO LAZZARA,
