Retelcall to Section Chief THOMAS J. McANDREWS this date, to secure authority to survey home of JOE R. DIEZ, Tampa, for possible misur installation. Authority granted and survey made this date.

The DIEZ home is presently in the final stages of construction, not yet occupied, and is situated in a tract of land of approximately 75 acres. The house is close to the Hillsborough River with the major portion of the land lying between the house and the only public road in the area. The land is fenced in and the house can be reached only by a long narrow sand road large enough for only one car at a time. Access can be more easily had from the river side by boat.

The house itself is a large expensive two-bedroom home of concrete block construction. It has a two-car garage and what appears to be a 10' x 10' vault with no windows and with all walls of at least eight inches thickness. The vault doorway is not finished but has heavy half-inch boards extending from the wall around the doorway as though to hold some heavy type of closing device. The vault is air-conditioned, heated by a ceiling-type heater, and has a telephone outlet.

The house has telephone wire installed and telephone outlets apparent in many places in the house, using three-wire

cable. The telephone lines do not approach the house at this time and it is assumed that the electrical poles will be used to carry the telephone wires due to the length of line needed. There are two three-pair beige telephone cables extending out of the house near the electrical cable entry, indicating possibly two telephones will be installed unless some type of alarm system is contemplated.

The house has a complete intercom system of the type using a radio receiver. Electrical service has been run into the house through the construction of a new line.

It is contemplated that two microphones will be installed, if possible, one to cover the vault area and one to cover the area of the small bar located in the living room. The MITE or MOUSE units will be used and this will be done prior to occupancy by the DIEZ family. The family has already moved in some personal belongings, and from the progress of the construction it is presumed they could move in completely within the next week or two. The survey indicates that misur coverage can be instituted with full security and an FD-142 will be submitted requesting authority to install.

The locks on the house are National "EZ-Set" locks and the Bureau is requested to immediately forward to Tampa any master or skeleton-type keys that might be of assistance in opening these locks.
