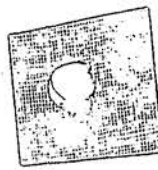
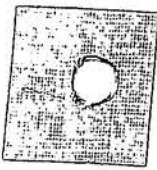

Chief OWENS stated he has been unable to verify this information and will arrest TRAFFICANTE on sight.

HARRY BROOKS, Manager of the Singapore Hotel, of Bal Harbour, states he is acquainted with subject as he was formerly connected with the Hotel Capri in Havana, Cuba, in the gambling casino at that hotel. He stated he saw TRAFFICANTE approximately two months ago at a restaurant on Miami Beach and has not seen him since. It was BROOKS' belief that anyone interested in gambling would not be at Miami Beach during this period as the beach is dead.
