MIAMI CHECK DI LIDO HOTEL FOR SUBJECTS LAST PRESENCE AND REGISTRATION THERE, DETERMINE SUBSCRIBER NUMBER CALLED BY JOE DIEZ NOTING DIEZ IS KNOWN TO HAVE BEEN IN MIAMI WITH SUBJECT AUGUST LAST AND DIEZ HAD CALLED THE LA SALLE APARTMENTS FROM THE DREAM BAR.
