SUBJECT: PH 701-C\*

RePHlet 11/25/64 advising of a change of telephone service at location of PH 701-C\*.

On 12/11/64 subject's telephone service changed to automatic type equipment with use of telephone instrument 564HBR. This equipment uses a 44A type connection block.

On date of change there was no opportunity to install altered 44A block to continue service of informant with complete security. Accordingly, as of 12/11/64 this source is not in operation.

Philadelphia is continuing efforts to make the previously described change with complete security. If change cannot be completed, the leased line will be cancelled and the source discontinued at an early date.
