## APPECIAL INVESTIGATIV DIVIS March 19, 19,5

Russell A. Bufalino, associate of La Cosa Nostra "commission" members and attendee at Apalachin meeting in November of 1957, was denied his petition to set aside original deportation order issued in 1958. Mrs. Bufalino's paramour and an informant of the Philadelphia Office, furnished testimony that was largely instrumental in denial of Bufalino's petition. Her informant relationship was not disclosed. Bureau furnished considerable additional information to assist Immigration and Naturalization Service in deportation hearing.
