4/10/71.

For the information of Miami and Newark, Legat,
Mexico City has advised that Mexican Immigration has circularized
all consulates and ports of entry to deny Lansky a visa or entry
to Mexico. CS MEX 287 advised 4/13/71 that Sam Giancana
reportedly departed from Mexico City about 3/23/71. No
information is available to indicate where he has gone.

Legat, Mexico City requests background information
on Caponigro as his file has been destroyed. Newark should
prepare a brief LHM including identifying data and physical
description of Caponigro for use of Legat, Mexico City.
Legat desires any lead data from any previous visit which
Caponigro may have made to Mexico possibly in 1956. If
available, this should also be included in LHM. Forward LHM to
Bureau for transmittal to Legat as soon as possible.

For information of Legat, Mexico City, Legat,
Tel Aviv has advised that Lansky was physically observed
4/14/71 at Dan Hotel, Tel Aviv. Israeli National Police
reported Lansky has not left Israel during recent period. (M)
