Assistant Attorney General Miller, of Criminal Division, telephoned and advised that the Attorney General desired we obtain telephone company records with reference to Jack Wasserman, a Washington, D. C., attorney. Wasserman is counsel for Carlos Marcello, the notorious hoodlum, who was deported to Guatemala by the Immigration and Naturalization Service earlier this month.

It was pointed out to Miller that while we desired to comply with the Attorney General's desires in this connection the deportation case had been handled by the Immigration and Naturalization Service. Miller was also informed, according to newspaper dispatches Wasserman had threatened to bring suit against the Attorney General in connection with the Marcello deportation. The reason for securing these telephone company records is unknown to the FBI but it might be the Department would want to consider this possible law suit in connection with any requests they might make of the FBI. It was also pointed out to Miller there could be no guarantee that any requests that might be made of the telephone company might not become known to Wasserman. Miller said he appreciated having these matters brought to his attention and under the circumstances no action should be taken by the FBI as he wanted to discuss this further with the Attorney General in light of the ramifications that existed. Accordingly, we are taking no further action pending further advice from the Department.
