SUBJECT: CARLOS MARCELLO
ANTI-RACKETEERING

My enclosed memorandum to you dated 4/28/61 reported results of discussion on 4/27/61 between Liaison Representative and Carl Wack, Immigration and Naturalization Service (INS) concerning situation wherein Marcello, notorious New Orleans hoodlum, is now trying to get back to U. S. from Guatemala where he was deported 4/4/61 by INS on basis of Guatemalan birth record subsequently revealed to be false. No comment was made by Liaison Representative when, during conversation, Wack said he feels one Bruce Kilby may be Bureau informant in this matter because Kilby went to Guatemala in 1956 with Carl Irving Noll. (Noll has admitted being involved in fabricating Marcello's birth record in 1956.) Regarding Wack's suggestion Kilby is our informant as to false birth record Director asked "Is he? H."

Kilby is not Bureau informant in this matter. Our informant is [redacted] associate of Marcello and an informant of New Orleans Division. Only reference to Kilby in Bureau files reflects that when we interviewed him on 5/29/58 he told us he never associated with Noll; that he knew Noll made trips to Guatemala; and that they talked about selling slot machines there. Kilby also said that when he knew Noll, he heard discussions and rumors regarding acquisition of Guatemalan citizenship by Marcello (62-302-33-4)
