CARLOS MARCELLO, AR. DEPARTMENT HAS ADVISED THAT ONE  
TED GOLDBERG, RELEASED FROM LEWISBURG PENITENTIARY  
JULY FOUR LAST, MET CARL IRVING NOLL, WITNESS UNDER SUBPOENA  
FOR GOVERNMENT IN MARCELLO CASE, IN WASHINGTON, D. C.,  
GOLDBERG TOLD NOLL TO SEE JACK WASSERMAN, ATTORNEY FOR  
SUBJECT. ALSO TOLD NOLL "YOU HAVE BEEN TALKING" THAT  
GOLDBERG HAD RECEIVED MONEY FROM COSTELLO AND THAT  
"COSTELLO WILL TAKE CARE OF YOU." FULL SIGNIFICANCE OF  
ABOVE NOT KNOWN. GOLDBERG ALLEGEDLY INDICATED THAT NOLL  
SHOULD COME TO CHICAGO WHERE HE WOULD RECEIVE MONEY FROM  
COSTELLO. GOLDBERG LEFT WASHINGTON FOR CHICAGO TO TAKE  
JOB JULY TEN NEXT WITH BIG FOUR CLOTHING CO., SIXTY THIRD

AND ASHLAND STREETS, CHICAGO. NO DESCRIPTION OF GOLDBERG

AVAILABLE OTHER THAN HE USES NAME "BURNEY" OR "BERNIE."

DEPARTMENT BELIEVES POSSIBLE OBSTRUCTION OF JUSTICE CASE INDICATED SINCE NOLL UNDER SUBPOENA. CHICAGO IMMEDIATELY FURNISH BACKGROUND ON BIG FOUR CLOTHING CO., INDICATING ANY KNOWN HOODLUM INFLUENCE IN COMPANY. ASCERTAIN ACTIVITIES OF GOLDBERG IN CHICAGO UTILIZING SURVEILLANCES, INFORMANTS AND APPROPRIATE INVESTIGATION. NEW YORK DETERMINE PRESENT LOCATION OF FRANK COSTELLO AND, IF POSSIBLE, ANY PLANS OF COSTELLO TO TRAVEL TO CHICAGO. PHILADELPHIA OBTAIN COMPLETE DESCRIPTION AND BACKGROUND ON GOLDBERG FROM LEWISBURG PENITENTIARY. BOTH COSTELLO AND GOLDBERG HAVE PERMISSION TO TRAVEL. CHICAGO ADVISE BUREAU OF ALL DEVELOPMENTS BY TELETYPE. NEW ORLEANS ADVISED BY MAIL.
