ReButel 7/10/61, instructing that four copies of all FD-302's recording past interviews by the FBI with CARL IRVING NOLL be forwarded to the Bureau by return mail.

The first contact this office had with NOLL was in the investigation of the case entitled "CARL IRVING NOLL, aka., ITSP; FRAUD BY WIRE - CONSPIRACY; MAIL FRAUD," Bureau file 87-33973. In this case NOLL was interviewed 2/1/57, by New Orleans Agents, the results of which were set out in report of SA JOHN T. REYNOLDS, 2/4/57, New Orleans. The interview with NOLL pertained to his involvement in the 87 case. This interview was conducted prior to the date the Bureau instituted the use of Form FD-302. Attached are four photostatic copies of pertinent pages out of SA REYNOLDS' report reflecting the interview with NOLL. SA REYNOLDS' report was made available to the U. S. Attorney, New Orleans.

NOLL was next interviewed 10/30/58, at Ashland, Kentucky, by an Agent of the Louisville Office. NOLL was interviewed at this time in connection with the MARCELLO investigation after PCI ______ of New Orleans (protect identity) had furnished information 2/7/58, that NOLL was instrumental in obtaining Guatemalan citizenship papers for MARCELLO and that NOLL had also transported some two or three hundred slot machines to Guatemala City. The results of the interview with NOLL at Ashland, Kentucky, were not disseminated to local agencies because the original information furnished by PCI _____ was disseminated to Internal Revenue Service, New Orleans, and U. S. Immigration and Naturalization Service, New Orleans, by letterhead
