On July 17, 1962, [redacted] Treasurer, Rand Development Company (source - protect), advised that WEBSTER has not visited the Rand Development Company since his return to the United States. However, he has called H. JAMES RAND asking if RAND could help him find a job. RAND, however, has made no efforts in this regard. [redacted] stated that he understands that WEBSTER's mother is still quite ill and subject has been spending all of his time at home due to his mother's condition. [redacted] stated that WEBSTER had contemplated doing an article for the "Saturday Evening Post" regarding his life in Russia, but had canceled it due to his mother's condition. [redacted] stated that as far as he knows, WEBSTER has no plans other than to stay at home.

No further investigation is warranted at Cleveland at this time and this case is being placed in a closed status.
