*	A survey was conducted by SA NATHAN O. BROWN of the Holiday Inn, Lafayette, Louisiana, on 6/12/64. This survey developed that the subject uses a twin room on his visits to the motel and that each of these rooms butts against another twin room. There is a telephone conduit connection on one side of each room which will afford direct air space between these units and is readily adaptable for use of a mite pre-amplifier unit.
	The ceilings in the motel are dropped, acoustical tile suspended by wire from rafters, the tile being tongue and groove and cannot be individually removed. Access can be gained to the space above the tile and an installation made there.
x. T	The walls are of cement block and use of a contact microphone would not be possible.
	It would appear that no satisfactory installation \mathcal{T} can be made without a degree of trespass and in view of the forthcoming trial of MARCELLO scheduled for August, 1964 in

U. S. District Court as well as the fact that he makes rather infrequent visits to Lafayette, it is not believed installation should be contemplated at this time. In the event it is felt that an installation is desirable a requestwill be made of the Bureau at that time.
