TP ONE TWENTY C ADVISED NIGHT OCT. TWENTY THREE THAT ON MONDAY MORNING , OCT. TWENTY ONE, SUBJECT WAS GONE FROM HIS RESIDENCE, HOWEVER, MRS. TRAFFICANTE REMARKED SUBJECT LEFT SUNDAY. NEITHER DESTINATION NOR MODE OF TRANSPORTATION MENTIONED. ABOUT TWO THIRTY P.M., TUESDAY, OCT. TWENTY TWO, SUBJECT ENTERED HIS RESIDENCE TAMPA ACCOMPANIED BY JAMES C. LONGO, ARRIVING IN LONGO-S CAR, AND SOURCE RELATES HE AND LONGO LEFT RESIDENCE ABOUT FOUR P.M. AT SEVEN THIRTY A.M., WEDNESDAY, OCT. TWENTY THREE, SUBJECT IN BED AT HIS RESIDENCE AND WAS HOME ALL DAY. NIGHT OF OCT. TWENTY THREE SUBJECT WAS TO TAKE WIFE TO DINNER AT COLUMBIAN RESTAURANT. SOURCE RELATES MRS.
