

SANTO TRAFFICANTE, JR., aka. SUBIECT:

'Re Bulet 9/30/63; which indicated the possibility that TRAFFICANTE had stayed at the "Guana Barh Palace Hotel" if he visited Brasilia in 1962 as was previously alleged.

On October 22, 1963, CS RIO-2 advised that a check of the Pecords of the "Guanabara Palace Hotel" in Rio de Janeiro failed to reveal that TRAFFICANTE had been a guest at that hotel at any time during 1962. Source noted, however that the records of the hotel are not well kept SIt is noted that Riolet of February 19, 1963, reflected that TRAFFICANTE had arrived in Rio de Janeiro on two occasions in 1962.
