MM EIGHT FOUR EIGHT DASH C ADVISED FIFTH LAST THAT SUBJECT FREQUENTING TOLEDO RESTAURANT, MIAMI. ALSO HEARD IN PAST SOME CUBANS HAVE ATTEMPTED TO GET ARMS AND AMMUNITION FROM SUBJECT FOR USE AGAINST CASTRO. HE WILL ATTEMPT TO IDENTIFY INDIVIDUALS OR GROUPS INVOLVED.
